ADDENDUM NO. 3 TO SOUTHERN PACIFIC PIPE LINES, INC.
MASTER LEASE PRC 5439

LESSEE: Southern Pacific Pipe
Lines, Inc.

AREA, TYPE LAND AND LOCATION:

Parcel 1: An 0.845-acre parcel of tide and submerged
land, located in the Sacramento River,
Sacramento and Yolo counties.

Parcel 2: An 0.599-acre parcel of tide and submerged
land, located in the American River,
Sacramento County.

LAND USE: Installation, operation and maintenance of
one 12-inch pipeline for transportation of
refined petroleum products.

TERMS OF MASTER LEASE:

Initial period: 20 years beginning January 1,
1978.

Renewal options: Two successive periods of
ten years each.

Public liability insurance: \$1,000,000 per
occurrence for bodily injury
and \$2,000,000 for property
damage.

2. Following approval of the presently recommended transaction, covering the Sacramento and American River parcels, the Applicant will have a total of 25 crossings over sovereign lands.
3. The January 26, 1978, action by the Commission provided for 19 Southern Pacific Pipe Lines, Inc. (SPPL) petroleum pipeline leases to be consolidated into one lease to streamline them into a systemwide approach. Rental was determined using the proration procedure contained in the Commission's general leasing regulations in 2 Cal. Adm. Code 2007. Changes, alterations or amendments to the lease can be made by mutual agreement of the parties. The proposed amendment adds only 1.444 acres to the master lease which would only cause a minimal increase in rental. Staff recommends maintaining the current annual rent until the next rent review which is due January 1, 1988.
4. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (14 Cal. Adm. Code 15025), the staff has prepared a Proposed Negative Declaration identified as EIR ND 413, State Clearinghouse No. 87020205. Such Proposed Negative Declaration was prepared and circulated for public review pursuant to the provisions of CEQA.

Based upon the Initial Study, the Proposed Negative Declaration, and the comments received in response thereto, there is no substantial evidence that the project will have a significant effect on the environment. (14 Cal. Adm. Code 15074(b))

5. This activity involves lands identified as possessing significant environmental values pursuant to P.R.C. 6370, et seq. but will not affect those significant lands.

PARCEL 1 (W 23821)

A parcel of tide and submerged land 50 feet wide in the bed of the Sacramento River, Sacramento and Yolo Counties, California, the centerline of which is described as follows:

BEGINNING at a point on the left bank of the Sacramento River which bears N 110°56'34" W, 776.52 feet from Monument 24-330 as shown on sheet 5 of 13 of that certain map entitled "Monument Survey, in Sacramento County in Sacramento between "L" Street and American River", prepared by the Transportation Department of the State of California and filed in the Right of Way Office, District Three, Department of Transportation, Marysville, California, said point of beginning having California Coordinate System of 1927, Zone 2 coordinates of N = 336,629.22 and E = 2,141,714.17; thence from said point of beginning N 83°59'54" W, 776.02 feet to the right bank of the Sacramento River and the end of the herein described line.

PARCEL 2 (W 23822)

A parcel of tide and submerged land 50 feet wide in the bed of the American River, Sacramento County, California, the centerline of which is described as follows:

BEGINNING at a point on the right bank of the American River which bears S 61°36'56" W, 1955.60 feet from Monument 24-256 as shown on sheet 2 of 4 of that certain map entitled "Monument Survey, in Sacramento County in Sacramento, between north end of American River Bridge and Route 80/160 Separation", prepared by District 3 of the Transportation Department of the State of California and filed in the Right of Way Office, District Three, Department of Transportation, Marysville, California, said point of beginning having California Coordinate System of 1927, Zone 2 coordinates of N = 337,256.42 and E = 2,157,375.62; thence from said point of beginning S 1°05'50" W, 742.00 feet to the left bank of the American River and the end of the herein described line.



