AMENDMENT TO UNITED STATES FISH AND WILDLIFE SERVICE
LEASE IN SOUTH SAN FRANCISCO BAY

APPLICANT: Department of the Interior
United States Fish and Wildlife Service

AREA, TYPE LAND AND LOCATION:
250, more or less, acres bay front lands,
vicinity of Fremont, Coyote Creek, Alameda
County.

LAND USE: National Wildlife Refuge.

TERMS OF ORIGINAL LEASE PRC 6045:

SIZE: 935, more or less, acres in and along South
San Francisco Bay in Alameda, San Mateo, and
Santa Clara counties, being tidelands and
submerged lands.

USE: National Wildlife Refuge.

TERM: Initial period: 66 years from September 1, 1981.

CONSIDERATION:
The operation, management, protection, and
maintenance of the lease premises.

OTHER PERTINENT INFORMATION:

1. The United States Fish and Wildlife Service holds a 935-acre Lease of State lands in South San Francisco Bay. Lands within the lease area have been put under a long term lease for the preservation of wetlands. At its meeting of August 20, 1981, the Commission approved the issuance of the lease, with the finding that the action was in the best interests of the State.
2. Property nearby the Alameda and Santa Clara County portion of the lands described in Lease PRC 6045 was the subject of a Compromise Settlement and Exchange Agreement (SLL 85) and a Mitigation Agreement between the Commission and Fremont International Partners, effective December 1, 1983, and a Memorandum of Understanding (MOU) between the Commission and the U.S. Fish and Wildlife Service, effective September 27, 1984. The terms of the Agreements and MOU specify the State is to receive title to 250, more or less, acres at which time the Commission shall add the property by amendment to the existing 66-year lease.
3. King and Lyons, a partnership, as assignee and successor to Fremont International Partners, has recently completed the terms of the Exchange and Mitigation Agreements by deeding the remainder of the 250 acres not previously deeded to the State.
4. Staff proposes to add by amendment to the 66-year lease the 250, more or less, acres described in Exhibit "A".
5. This proposal is considered to be in the State's best interest because it will enhance wetlands preservation in the baylands and assure their long-term protection.

6. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (14 Cal. Adm. Code 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorical exempt project. The project is exempt under Class 13, an Acquisition and Lease of Lands for Wildlife Conservation Purposes.


