TYPE OF LAND AND LOCATION:
State School Land - Section 16, T18N R6E, SBBM, -
San Bernardino County, Approximately 16 miles
southwest of Tecopa.

LAND USE: Prospecting for valuable minerals.

TERM: The two-year mineral prospecting permit was
issued effective April 1, 1987. Executed
quitclaim deed received by staff on
November 13, 1987.

REASON FOR QUITCLAIM:
Permittee drilled 15 churn drill holes to a
maximum depth of 30 feet and 18 pneumatic drill
holes to a depth of 10 feet. Assay results of
samples do not indicate the presence of
commercial quantities of precious metals.
Further work is not warranted at this time.

PREREQUISITE ITEMS:

- A. Quitclaim deed duly executed by Permittee.
- B. Permittee has complied with Paragraph 18 of the permit which requires restoration of the land, as nearly as possible, to the condition existing on the date the permit took effect.

OTHER PERTINENT INFORMATION:

Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (14 Cal. Adm. Code 15061), the staff has determined that this activity is exempt from the requirements of the CEQA, because it is not a "project" as defined by CEQA and the State CEQA Guidelines.
