SIXTH MODIFICATION OF THE 1987-1988  
PLAN OF DEVELOPMENT AND OPERATIONS AND BUDGET  
LONG BEACH UNIT, WILMINGTON OIL FIELD  
LOS ANGELES COUNTY

The City of Long Beach has submitted to the Commission the Sixth Modification of the 1987-1988 Plan of Development and Operations and Budget, Long Beach Unit. The Sixth Modification would modify the Plan to provide for the replacement of a large oil storage tank with two smaller tanks. Budget fund transfer will be made in the amount of \$1,721,000 into the Oil and Gas Production Program to fund this project and to reallocate funding for three expense Budget Items and Administrative Overhead.

One of the two 87,000 barrel oil storage/shipping tanks on Pier J has developed a bottom leak. Replacement of this tank with two smaller tanks is not only more cost effective than repairing the tank but will also improve operating efficiency at the facility. (The bottom of the other 87,000 tank was replaced some years ago). Total cost of the project is estimated at \$850,000 of which \$650,000 would be transferred with this modification for purchasing and installing the new tanks.

This modification would also transfer \$105,000 to the Waste Disposal Budget Item and \$800,000 to the Leasehold Improvements Budget Item in the Oil and Gas Production Program. Expenditures are now charged to these Budget Items and similar Budget Items in the Drilling and Development Program as applicable rather than as a fixed percentage of total expenditures. This improvement in tracking expenditures does require budget adjustments in the transition year.

Additional funding is also requested for the Fresh Water Budget Item. To provide for an increase in the cost of water, \$100,000 is needed in this Budget Item, a 37% increase

The funds needed for these Budget Items would be transferred from the Leasehold Improvements and Waste Disposal Budget Items in the Drilling and Development Program and the Produced Water Handling Budget Item in the Water Injection Program.

Funds would be transferred as necessary to adjust Administrative Overhead for the affected Programs.
