MAINTENANCE DREDGING PERMIT

APPLICANT: North Tahoe Marina, Inc.
7360 North Lake Boulevard
Tahoe Vista, California 95732

AREA, TYPE LAND AND LOCATION:
Sovereign lands in Lake Tahoe at North Tahoe
Marina in Tahoe Vista, Placer County.

LAND USE: Dredge a maximum 2,721 cubic yards of material
at the existing marina to maintain a navigable
depth previously established by the Corps of
Engineers.

A large backhoe or clamshell will be used to
remove the material and a turbidity screen will
be installed around the entire outside of the
marina during the operation. The dredged
material will then be hauled by truck to the
Eastern Placer County landfill as approved by
the Tahoe Regional Planning Agency and the
Lahontan Water Quality Control Board.

TERMS OF PROPOSED PERMIT:

Initial period: One (1) year commencing
May 10, 1988.

Royalty: \$0.25 per cubic yard for
material placed at the
approved disposal site.

OTHER PERTINENT INFORMATION:

1. The current low level of Lake Tahoe has created a serious problem within the marina with respect to adequate depth for launching power and sail boats.
2. This activity involves lands identified as possessing significant environmental values pursuant to P.R.C. 6370, et seq. Based upon the staffs' consultation with the persons nominating such lands and through the CEQA review process, it is the staffs' opinion that the project, as proposed, is consistent with its use classification.
3. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (14 Cal. Adm. Code 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorical exempt project. The project is exempt under Class 4(g), maintenance dredging, where the spoil is deposited in a spoil area authorized by all applicable State and Federal regulatory agencies, 14 Cal. Adm. Code 15104.

Authority: P.R.C. 21084 and 14 Cal. Adm. Code 15300.

IT IS RECOMMENDED THAT THE COMMISSION:


1. FIND THAT THE ACTIVITY IS EXEMPT FROM THE REQUIREMENTS OF THE CEQA PURSUANT TO 14 CAL. ADM. CODE 15061 AS A CATEGORICAL EXEMPT PROJECT, CLASS 4(g), MAINTENANCE DREDGING, 14 CAL. ADM. CODE 15104.
2. FIND THAT THIS ACTIVITY IS CONSISTENT WITH THE USE CLASSIFICATION DESIGNATED FOR THE LAND PURSUANT TO P.R.C. 6370, ET SEQ.
3. AUTHORIZE STAFF TO ISSUE TO NORTH TAHOE MARINA, THE DREDGING PERMIT AUTHORIZING DREDGING A MAXIMUM 2,721 CUBIC YARDS OF MATERIAL TO MAINTAIN A NAVIGABLE DEPTH PREVIOUSLY AUTHORIZED BY THE CORPS OF ENGINEERS FOR ONE YEAR COMMENCING MAY 10, 1988, FROM LAKE TAHOE AT NORTH TAHOE MARINA, PLACER COUNTY, AND DISPOSAL AT THE EASTERN PLACER COUNTY LANDFILL AS APPROVED BY THE TAHOE REGIONAL PLANNING AGENCY AND THE LAHONTAN REGIONAL WATER QUALITY CONTROL BOARD. A ROYALTY OF \$0.25 PER CUBIC YARD SHALL BE CHARGED FOR MATERIAL PLACED AT THE APPROVED DISPOSAL SITE. SUCH PERMITTED ACTIVITY IS CONTINGENT UPON APPLICANT'S COMPLIANCE WITH APPLICABLE PERMITS, RECOMMENDATIONS OR LIMITATIONS ISSUED BY FEDERAL, STATE AND LOCAL GOVERNMENT AGENCIES.


