APPROVAL OF AND AUTHORIZATION TO EXECUTE COMPROMISE TITLE  
SETTLEMENT AND EXCHANGE AGREEMENT WITH  
N. B. HUNT AND W. H. HUNT  
INVOLVING LANDS IN AND ADJACENT TO BATIQUITOS LAGOON,  
CITY OF CARLSBAD, SAN DIEGO COUNTY

The Private Parties hold record title to certain lands in Batiquitos Lagoon as successors-in-interest to original purchasers of Swamp and Overflowed patents issued in 1887 by the State. The Private Parties own additional lands adjacent to Batiquitos Lagoon conveyed by the United States as public lands. The Lagoon was originally surveyed and meandered by the United States as salt marsh in 1875 and later, in 1905, designated as swamp and overflowed lands and patented to California by the United States. The area designated as salt marsh contained 601.07 acres.

The staff of the Commission believes, based on available data, that Batiquitos Lagoon contained tide and submerged lands under natural conditions, which was prior to the artificial influences of railroad fill in the 1880's and subsequent highway fills which have severely constricted the natural tidal prism of the Lagoon.

The Commission, on December 30, 1985, approved, by Minute Item #1, a title settlement and exchange agreement with William C. Savage, et al involving property directly adjacent to and west

of the subject property, by which the State acquired approximately four acres of land in the bed of Batiquitos Lagoon and an adjacent 40-foot-wide public access easement connecting Batiquitos Drive, a public street, to the property boundary adjoining the subject property.

On July 24, 1986, the Commission, pursuant to Minute Item #30, authorized the acceptance of certain property interests which involved approximately 26 acres of land within the Lagoon which had been offered for dedication by Sammis' Properties as a condition of a California Coastal Commission permit.

The effect of the subject agreement and the two previously mentioned, in addition to previous acquisition by the Wildlife Conservation Board, will bring nearly all of the wetlands (approximately 600 acres) into State ownership.

The confirmation of these properties in State ownership is a major step by the Commission in making the restoration of the Lagoon possible. The Commission previously approved a Memorandum of Agreement (MOA) for restoration of the Lagoon by Minute Item #39 at the Commission's September 23, 1987 meeting. That agreement was executed by the Port of Los Angeles, the United States Fish and Wildlife Service, the California Department of Fish and Game, the National Marine Fisheries Services, the City of Carlsbad, and the State Lands Commission on November 12, 1987. The MOA provides for the restoration and enhancement of 596+ acres for marine habitat within the Lagoon.

The State Lands Commission, pursuant to the MOA, has been identified as the appropriate agency to hold title to the Lagoon in conjunction with the potential restoration project and consistent with Chapter 1415, Statutes of 1986, which authorizes restoration of the Lagoon with tideland trust revenues of the Port of Los Angeles. The lands are intended to be leased to the Department of Fish and Game for inclusion in an Ecological Reserve.

The parties acknowledge that there are uncertainties regarding whether some or all of Batiquitos Lagoon consisted of tide lands or tide and submerged lands, or swamp and overflowed lands, or a combination thereof, as well as the respective boundaries of such lands. This uncertainty is due not only to the scarcity of historical data, interpretive problems of the data available, and the possible effect of both natural and

man-made influences, but also the interpretation of relevant legal principles. Therefore, the resolution of the uncertainties by agreement, thereby eliminating the potential of protracted, costly, and vigorously disputed litigation with uncertain results, is in the parties best interest.

In order to effectuate the MOA and provide certainty to public versus private property interests in the area, staff of the Commission, together with the Office of the Attorney General, have negotiated a settlement agreement with representatives of Hunt Properties, Inc. which will result in the conveyance to the State of a fee interest to an approximate 383-acre parcel of land which includes all of the Hunt-owned lands in Batiquitos Lagoon designated by the United States Army Corps of Engineers, United States Fish and Wildlife Service, and California Department of Fish and Game as wetlands along with some additional littoral areas. These wetlands have been identified as necessary for inclusion within the proposed restoration and enhancement project for the Lagoon.

The staff of the Commission has evaluated its potential economic and public trust interest in the Upland Property described in Exhibit "B" and depicted on Exhibit "D" and has determined that those values are equal to or less than the value of the Lagoon property to be conveyed to the State as described in Exhibit "A" and depicted on Exhibit "D".

The State will, in exchange for the Private Parties' interest in the Lagoon Parcel (Exhibit "A"), quitclaim any interest it may have based on potential sovereign interest claims in Upland Parcel (Exhibit "B").

In addition to the issues involving the potential interest in Batiquitos Lagoon, a question exists involving the extent and areas of possible public prescriptive or implied dedication rights for public access and recreational use on the Upland Parcel. The staff of the Commission and Office of the Attorney General have investigated facts and reviewed evidence of public use and have concluded that the negotiated settlement provided for by this agreement, which will confirm, compromise, and locate such interest, is just, equitable, and in the best interest of the Public and the State.

Private Parties will grant to the State a 40 foot public access easement over a portion of the Hunt Upland Property within the first 100 feet landward of the boundary with the Lagoon parcel,

in exchange for the State's relinquishment of any further implied dedication claims over other portions of the Upland Property. Actual improvements of the accessway will be subject to the approval of the California Coastal Commission. The public access easement is depicted on Exhibit C and connects public access to and along the shoreline of Batiquitos Lagoon. There will also be two trail heads which provide a minimum 20 spaces of off-street parking available for use, free of charge, to the general public.

In addition, the access trail will include observation points, interpretive kiosks, an outdoor classroom, and picnic areas. The construction and maintenance obligations associated with these public areas will be accepted by the developer.

This agreement and all actions required to effectuate this Agreement are exempt from the provisions of the Subdivision Map Act (Gov. Code, Sec. 66412[e]), the California Coastal Act (P.R.C. 30416[c]) and the California Environmental Quality Act (P.R.C. 21080.11).

This action by the Commission does not operate, by implication or otherwise, to satisfy or affect the mitigation, regulatory requirements, or jurisdiction of any other public agency or body (including, without limitation, the California Coastal Commission) with respect to any development proposals concerning the Hunt Upland Property, or to exempt any proposed development of such uplands from the California Coastal Act (P.R.C. 30000, et seq.), or from the California Environmental Quality Act (P.R.C. 21000-21177).

IT IS RECOMMENDED THAT THE COMMISSION:

2. AUTHORIZE THE EXECUTION AND RECORDATION ON BEHALF OF THE COMMISSION OF A TITLE SETTLEMENT AND EXCHANGE AGREEMENT (AD 75) BETWEEN THE STATE, ACTING BY AND THROUGH THE STATE LANDS COMMISSION, AND N. B. HUNT AND W. H. HUNT (PRIVATE PARTIES) IN SUBSTANTIALLY THE FORM OF THAT AGREEMENT ON FILE IN THE SACRAMENTO OFFICE OF THE COMMISSION.
3. FIND AND DECLARE THAT UPON THE EFFECTIVE DATE OF THE ABOVE-REFERENCED AGREEMENT:
  - A. THE AREA OF THE STATE'S SOVEREIGN INTEREST CLAIMS TO BE CONVEYED TO THE PRIVATE PARTIES CONSTITUTE A RELATIVELY SMALL AREA WITHIN THE HISTORIC BED OF BATIQUITOS LAGOON AND HAS BEEN IMPROVED, FILLED, AND RECLAIMED, AND HAS THEREBY BEEN EXCLUDED FROM THE PUBLIC CHANNELS AND IS NO LONGER AVAILABLE OR USEFUL OR SUSCEPTIBLE OF BEING USED FOR COMMERCE, NAVIGATION AND FISHERY, AND IS NO LONGER, IN FACT, TIDELANDS OR SUBMERGED LANDS. SUCH LAND SHALL BE FREE FROM THE PUBLIC TRUST FOR COMMERCE, NAVIGATION AND FISHERY.
  - B. THE LANDS DESCRIBED IN EXHIBIT "A" TO BE ACQUIRED BY THE STATE, PURSUANT TO THIS SETTLEMENT AGREEMENT, ARE GREATER THAN OR EQUAL IN VALUE TO THE LANDS OR INTERESTS IN LANDS BEING CONVEYED TO PRIVATE PARTIES WITHIN THE UPLAND PARCEL (EXHIBIT "B").
  - C. THE LANDS, OR INTERESTS IN LANDS, BEING CONVEYED TO THE STATE BY PRIVATE PARTIES, PURSUANT TO THIS AGREEMENT, ARE ACCEPTED AS AND SHALL BE SOVEREIGN LANDS OF THE STATE AND, AS SUCH, ARE SUBJECT TO THE PUBLIC TRUST FOR COMMERCE, NAVIGATION, AND FISHERY.
  - D. THE PUBLIC ACCESS EASEMENT CONVEYED BY THE PRIVATE PARTIES TO THE STATE, AS DESCRIBED IN EXHIBIT "C" AND DEPICTED ON EXHIBIT "D", TOGETHER WITH THE COVENANTS TO IMPROVE AND MAINTAIN THE ACCESS AND ANCILLARY PUBLIC FEATURES, IS A FAIR AND EQUITABLE SETTLEMENT OF CLAIMS OF IMPLIED DEDICATION ON THE UPLAND PROPERTY.
  - E. THE SETTLEMENT OF THIS SOVEREIGN PROPERTY TITLE AND IMPLIED DEDICATION DISPUTE IS IN THE BEST INTEREST OF THE PUBLIC AND STATE.

4. AUTHORIZE THE STAFF OF THE STATE LANDS COMMISSION AND THE OFFICE OF ATTORNEY GENERAL TO TAKE ALL FURTHER STEPS NECESSARY TO IMPLEMENT THE TERMS AND PROVISIONS OF THIS AGREEMENT, INCLUDING, BUT NOT LIMITED TO, EXECUTION OF ALL DOCUMENTS, MAPS, DEEDS, TITLE AND ESCROW INSTRUCTIONS, CERTIFICATES OF ACCEPTANCE AND CONSENT TO RECORDATION, AND APPEARANCES IN ANY LEGAL PROCEEDINGS WHICH MAY BE REQUIRED IN ORDER TO FINALIZE THE AGREEMENT.




