GENERAL LEASE - RIGHT-OF-WAY USE

APPLICANT: Harwood Products  
P.O. Box 224  
Branscomb, California 95417

AREA, TYPE LAND AND LOCATION:  
A 1.5±-acre parcel of State school land within  
Section 4 and Section 6, T23N, R11W, M.D.M.,  
Mendocino County.

LAND USE: Use of existing roads for timber hauling.

TERMS OF PROPOSED LEASE:

Initial period: Two (2) years beginning  
September 1, 1988.

Special: Applicant is self-insured for  
\$1,000,000.

CONSIDERATION: \$100 per annum.

BASIS FOR CONSIDERATION:

Pursuant to 2 Cal. Adm. Code 2003.

OTHER PERTINENT INFORMATION:

1. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (14 Cal. Adm. Code 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 1, Existing Facilities, 2 Cal. Adm. Code 2905(a)(2).

Authority: P.R.C. 21084, 14 Cal. Adm. Code 15300, and 2 Cal. Adm. Code 2905.

2. The Lessee, as a condition of the Right-of-Way agreement, will abide by the policies set forth in the Z'berg - Nejedly Forest Practice Act of 1973.
3. A Timber Harvesting Plan (THP No. 1-88-470 men); covering this activity, has been filed, reviewed, and approved by the California Department of Forestry.
4. All activities performed under this agreement will be done or approved by a Registered Professional Forester.
5. Any roads used by the Lessee will be restricted to those that are existing; no new construction will occur.




