**RENEWAL OF LEASE PRC 415**

**APPLICANT:** Pacific Gas and Electric Company  
1919 Webster Street  
Oakland, California 94612

**AREA, TYPE LAND AND LOCATION:**  
A 0.87-acre parcel of tide and submerged  
land in the San Joaquin River near Antioch,  
Contra Costa County.

**LAND USE:** Maintenance and operation of a cooling water  
intake structure and appurtenances.

**TERMS OF ORIGINAL LEASE:**

Initial period: 20 years beginning June 14,  
1949.

Renewal options: Three (3) additional periods  
of ten years each.

Surety bond: \$5,000.

Consideration: \$46.68 per annum.

Other than revisions to area and consideration,  
all other terms remained unchanged.

**TERMS OF FIRST TEN-YEAR RENEWAL - 06/14/69 to 06/13/79:**

Consideration: \$887.40 per annum.

**BASIS FOR CONSIDERATION:**

Six percent (6%) of appraised value of land.

TERMS OF SECOND TEN-YEAR RENEWAL - 06/14/79 to 06/13/89:

Consideration: \$2,088 per annum.

BASIS FOR CONSIDERATION:

Eight percent (8%) of appraised value of land.

TERMS OF PROPOSED THIRD TEN-YEAR RENEWAL

Ten years from June 14, 1989  
through June 13, 1999.

CONSIDERATION: \$2,745 per annum; with the State reserving the  
right to fix a different rental on each  
fifth anniversary of the lease.

BASIS FOR CONSIDERATION:

Nine percent (9%) of appraised value of land.

PREREQUISITE CONDITIONS, FEES AND EXPENSES:

United States Army Corps of Engineers permit  
issued.

APPLICANT STATUS:

Applicant is owner of upland.

STATUTORY AND OTHER REFERENCES:

OTHER PERTINENT INFORMATION:

1. Pursuant to the Commission's delegation of  
authority and the State CEQA Guidelines  
(14 Cal. Code Regs. 15061), the staff has  
determined that this activity is exempt  
from the requirements of the CEQA as a  
categorically exempt project. The project  
is exempt under Class 1, Existing  
Facilities, 2 Cal. Code Regs 2905(a)(2).

Authority: P.R.C. 21084, 14 Cal. Code  
Regs. 15300, and 2 Cal. Code Regs. 2905.

2. This project is situated on State land identified as possessing significant environmental values pursuant to P.R.C. 6370.1, and is classified in a use category, Class "B", which authorizes Limited Use.
3. Staff review indicates that there will be no significant effect upon the identified environmental values. This is an existing facility for which no adverse comments have been received.

IT IS RECOMMENDED THAT THE COMMISSION:

1. FIND THAT THE ACTIVITY IS EXEMPT FROM THE REQUIREMENTS OF THE CEQA PURSUANT TO 14 CAL. CODE REGS. 15061 AS A CATEGORICALLY EXEMPT PROJECT, CLASS 1, EXISTING FACILITIES, 2 CAL. CODE REGS. 2905(a)(2).
2. AUTHORIZE ISSUANCE TO PACIFIC GAS AND ELECTRIC COMPANY OF A TEN-YEAR RENEWAL OF LEASE PRC 415, BEGINNING JUNE 14, 1989; IN CONSIDERATION OF ANNUAL RENT IN THE AMOUNT OF \$2,745, WITH THE STATE RESERVING THE RIGHT TO FIX A DIFFERENT RENTAL ON EACH FIFTH ANNIVERSARY OF THE LEASE; FOR THE CONTINUED MAINTENANCE AND OPERATION OF A COOLING WATER INTAKE STRUCTURE AND APPURTENANCES ON THE LAND DESCRIBED ON EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART HEREOF.


