PERTINENT INFORMATION:

State Geothermal Resources Lease PRC 6378 was issued to Kennecott Corporation on July 1, 1987. The lease was later assigned on November 1, 1987 to Kennecott Explorations (Australia) Ltd.

State Geothermal Prospecting Permit PRC 6552 was issued to Bear Creek Mining Company, exploration subsidiary of Kennecott Corporation, on January 24, 1984. The permit was assigned to Kennecott Explorations (Australia) Ltd. on November 1, 1987. Appearing on today's agenda is consideration for conversion of the prospecting permit to a Geothermal Resources Lease PRC 6552.

Kennecott Explorations (Australia) Ltd. has requested Commission approval of the assignment of Geothermal Resource Leases PRC 6378 and PRC 6552 to Freeport-McMoRan Resources Partners, Limited Partnership.

OTHER PERTINENT INFORMATION:

1. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (14 Cal. Code Regs. 15061), the staff has determined that this activity is exempt from the requirements of the CEQA because it is not a "project" as defined by CEQA and the State CEQA Guidelines.
