AREA, TYPE LAND AND LOCATION:

A 0.918-acre parcel of submerged land in the
San Joaquin River, Fresno and Madera counties.

CALENDAR ITEM NO. C18 (CONT'D)

LAND USE: Maintenance of an existing bridge crossing, approach embankments and riprap bank protection.

TERMS OF CURRENT LEASE:

Initial period: 25 years beginning July 1, 1977.

Surety bond: \$2,000.

Public liability insurance: Combined single limit coverage of \$500,000.

Consideration: The annual rental shall be the greater of the following: The number of tons of bulk commodities (sand and gravel) passing over State land multiplied by \$0.002278 or \$1,000; with the State reserving the right to fix a different rental on each fifth anniversary of the lease.

BASIS FOR CONSIDERATION:

Pursuant to 2 Cal. Adm. Code 2003.

PREREQUISITE CONDITIONS, FEES AND EXPENSES:

Processing fees have been received.

OTHER PERTINENT INFORMATION:

1. On July 19, 1978, the State Lands Commission approved a General Lease - Right-of-Way Use to Lone Star Industries, Inc. During 1987, the corporation reorganized and transferred assets necessitating two assignments of the lease:

- a) The first assignment is to Lone Star California, Inc., and New York Trap Rock Corporation, effective December 2, 1987;
 - b) The second assignment is to Lone Star California, a California general partnership, effective December 3, 1987, which changed its name to RMC Lonestar, a California general partnership, effective December 31, 1987.
2. Amendment of lease PRC 5514 to incorporate provisions governing the assignment, encumbrancing and subletting of the lease as set forth in that "First Amendment to Lease PRC 5514" is on file with the Commission.
 3. This activity involves lands identified as possessing significant environmental values pursuant to P.R.C. 6370, et seq. but will not affect those significant lands.
 4. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (14 Cal. Adm. Code 15061), the staff has determined that this activity is exempt from the requirements of the CEQA because the activity is not a "project" as defined by CEQA and the State CEQA Guidelines.

IT IS RECOMMENDED THAT THE COMMISSION:

1. FIND THAT THE ACTIVITY IS EXEMPT FROM THE REQUIREMENTS OF THE CEQA PURSUANT TO 14 CAL. ADM. CODE 15061 BECAUSE THE ACTIVITY IS NOT A PROJECT AS DEFINED BY P.R.C. 21065 AND 14 CAL. ADM. CODE 15378.

2. AUTHORIZE ISSUANCE OF AN ASSIGNMENT OF LEASE PRC 5514, ON FILE IN THE PRINCIPAL OFFICE OF THE STATE LANDS COMMISSION, TO LONE STAR CALIFORNIA, INC. AND NEW YORK TRAP ROCK CORPORATION, EFFECTIVE DECEMBER 2, 1987, ALL TERMS AND CONDITIONS OF PRC 5514 REMAIN UNCHANGED AND IN FULL FORCE AND EFFECT.
3. AUTHORIZE ISSUANCE OF AN ASSIGNMENT OF LEASE PRC 5514, ON FILE IN THE PRINCIPAL OFFICE OF THE STATE LANDS COMMISSION, TO LONE STAR CALIFORNIA, A CALIFORNIA GENERAL PARTNERSHIP, EFFECTIVE DECEMBER 3, 1987, WHICH PARTNERSHIP HAS NOW CHANGED ITS NAME TO RMC LONESTAR, A CALIFORNIA GENERAL PARTNERSHIP; ALL TERMS AND CONDITIONS OF PRC 5514 REMAIN UNCHANGED AND IN FULL FORCE AND EFFECT.
4. AUTHORIZE THE AMENDMENT OF LEASE PRC 5514 TO INCORPORATE PROVISIONS GOVERNING THE ASSIGNMENT, ENCUMBRANCING, AND SUBLETTING OF THE LEASE AS SET FORTH IN THE "FIRST AMENDMENT TO LEASE PRC 5514" ON FILE WITH THE COMMISSION, AND BY REFERENCE MADE A PART HEREOF; ALL OTHER TERMS AND CONDITIONS REMAIN UNCHANGED AND IN FULL FORCE AND EFFECT.


