AREA, TYPE LAND AND LOCATION:

A 12.97-acre parcel of State school land in the
west half of Section 16, T19S R41E, MDM, Inyo
County.

LAND USE:

Operation and maintenance of existing utility
lines (4-inch water pipeline, electric power
line, and a telephone line.)

TERMS OF EXISTING LEASE:

Initial period: 15 years beginning May 9,
1977.

Renewal options: One successive period of ten
years each.

Surety bond: \$3,000.

Public liability insurance: Combined single
limit coverage of \$150,000.

Consideration: \$412.80 per annum; five-year
rent review.

2. Assignee purchased Darwin Mine Property from the Assignor on February 28, 1989.


