APPROVAL OF 4 GENERAL PERMIT - PUBLIC AGENCY USE

APPLICANT: California Department of Fish and Game
601 Locust Street
Redding, California 96001

AREA, TYPE LAND AND LOCATION:
A 0.004-acre parcel of submerged land located
in the Sacramento River at the
Anderson-Cottonwood Irrigation District Dam,
Shasta County.

LAND USE: Construction, use, and maintenance of a fish
ladder to be installed on the existing dam.

TERMS OF PROPOSED PERMIT:
Initial period: 49 years beginning
October 26, 1989.

CONSIDERATION: The public use and benefit, with the State
reserving the right at any time to set a
monetary rental if the Commission finds such
action to be in the State's best interest.

BASIS FOR CONSIDERATION:
Pursuant to 2 Cal. Code Regs. 2003.

APPLICANT STATUS:
Applicant is permittee of upland.

PREREQUISITE CONDITIONS, FEES AND EXPENSES:
Filing fee has been received.

OTHER PERTINENT INFORMATION:

- 1. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (14 Cal. Code Regs. 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 4, Minor Alteration to Land, 14 Cal. Code Regs. 15304.

Authority: P.R.C. 21084 and 14 Cal. Code Regs. 15300.

- 2. The proposed project will be located at the south end of the Anderson-Cottonwood Irrigation District Dam at Redding. The purpose of the project is to provide improved fish passage at the Dam.
- 3. No wetland or riparian vegetation will be removed or impacted.
- 4. The Applicant has obtained an agreement with the Anderson-Cottonwood Irrigation District for the construction.
- 5. The Applicant has requested the processing fee be waived due to the fact that the fish ladder will be used by thousands of salmon each year during their upstream migration, including winter-run chinook whose population is at very low levels. The project will be a public benefit by increasing the salmon population.

Shasta County, United States Army Corps of Engineers, and Anderson-Cottonwood Irrigation District.

IT IS RECOMMENDED THAT THE COMMISSION:

1. FIND THAT THE ACTIVITY IS EXEMPT FROM THE REQUIREMENTS OF THE CEQA PURSUANT TO 14 CAL. CODE REGS. 15061 AS A CATEGORICALLY EXEMPT PROJECT, CLASS 4, MINOR ALTERATION TO LAND, 14 CAL. CODE REGS. 15304.
2. FIND IT IN THE STATE'S BEST INTEREST TO WAIVE THE PROCESSING FEE.
3. AUTHORIZE ISSUANCE TO THE CALIFORNIA DEPARTMENT OF FISH AND GAME OF A 49-YEAR GENERAL PERMIT - PUBLIC AGENCY USE, BEGINNING OCTOBER 26, 1989; IN CONSIDERATION OF THE PUBLIC USE AND BENEFIT WITH THE STATE RESERVING THE RIGHT AT ANY TIME TO SET A MONETARY RENTAL IF THE COMMISSION FINDS SUCH ACTION TO BE IN THE STATE'S BEST INTEREST; FOR THE INSTALLATION, USE, AND MAINTENANCE OF A FISH LADDER ON THE LAND DESCRIBED ON EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART HEREOF.

EXHIBIT "A"
LAND DESCRIPTION

W 24309

A parcel of submerged land in the Sacramento River lying immediately beneath the fish ladder at Anderson-Cottonwood Irrigation District Dam at Caldwell Park, Redding, Shasta County, California.

EXCEPTING THEREFROM any portion lying landward of the ordinary low water mark of the Sacramento River.


