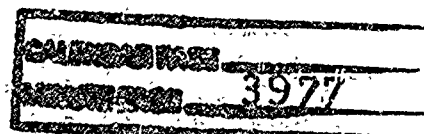
Also present was Jim Tucker, Commission-Alternate for Gray Davis, State Controller.

Chairman Leo McCarthy announced before taking up the calendar items that the State Lands Commission will have a seat change occurring in leadership. Chairman McCarthy announced that our chief Executive Officer, Claire Dedrick, is leaving the position of CEO after years of outstanding service. Also Chairman McCarthy presented Ms. Dedrick with a resolution for her outstanding job here at the State Lands Commission.

Before concluding with the Commission's business, action was taken on the replacement for Claire T. Dedrick.
