CLOSING ACCOUNTS OF TIDELANDS OIL REVENUE EXPENDITURES
FOR SUBSIDENCE VERTICAL AND HORIZONTAL MEASUREMENTS
AND STUDIES, CITY OF LONG BEACH, LOS ANGELES COUNTY
1988-89 FISCAL YEAR

SUBSIDENCE PROJECT:

Subsidence vertical and horizontal measurements
and studies in the City of Long Beach Harbor
District between July 1, 1988 and June 30, 1989.

STATUTORY AUTHORITY:

Chapter 138/'64 1st E.S., Sections 1(e) and
4(d).

FISCAL IMPACT:

Total costs amount to \$195,985.94 and are
payable to the City from tideland oil revenues
in accordance with Chapter 138 Section 4(d).

COMMISSION PRIOR APPROVAL:

June 30, 1988, Minute Item 33.

CONDITIONS FULFILLED:

1. That the amounts, if any, to be allowed ultimately as subsidence costs deductible under Chapter 138/'64 1st E.S., Section 4(d) would be determined by the Commission upon an engineering review and final audit by Commission staff after the work was completed.
2. That the scope of work performed is essentially in conformance with details of such work as previously defined by the Commission.

OTHER PERTINENT INFORMATION:

1. On June 30, 1988, the Commission granted prior approval to the City of Long Beach for \$250,000 in subsidence cost expenditures to be used in the conduct of vertical and horizontal measurements and studies in the Long Beach Harbor District during the 1988-89 fiscal year. The work consists of analysis and interpretation of data developed from twice yearly elevation and linear surveys carried out through an established network of ground control points dispersed throughout the project area. The purpose is to detect the occurrence, if any, of subsidence of the land surface. The vertical (elevation) surveys are conducted each May and November and the horizontal (linear) surveys are conducted each February and August. No significant change in the Harbor District land surface was detected during 1988-89.

Expenditures for the vertical measurements and studies were less than the prior approved amount by \$47,062.76. The cost of the horizontal measurements and studies was less than the amount approved by \$6,951.30. A staff audit confirms the incurred charges. The cost savings were due primarily to efforts by the Harbor Department survey staff to reduce expenditures by applying state of the art technology and the elimination of a number of redundant bench marks.

2. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (14 Cal. Code Regs. 15061), the Commission's review of this activity is exempt from the requirements of the CEQA because it is not a "project" as defined by CEQA and the State CEQA Guidelines.
