ASSIGNMENT OF GENERAL PERMIT - RECREATIONAL USE

ASSIGNOR: Dale R. Baker

AREA, TYPE LAND AND LOCATION:  
A 0.022-acre parcel of tide and submerged land  
located in the San Joaquin River at Mossdale  
Trailer Park, San Joaquin County.

LAND USE: Maintenance of an existing floating dock  
utilized for recreational purposes.

TERMS OF ORIGINAL PERMIT:  
Initial period: Ten years beginning  
January 1, 1987.

Public liability insurance: Combined single  
limit coverage of \$100,000  
per occurrence for bodily  
injury and property damage.

CONSIDERATION: \$66.78 per annum; with the State reserving the  
right to fix a different rental on each  
fifth anniversary of the permit.

BASIS FOR CONSIDERATION:  
Pursuant to 2 Cal. Code Regs. 2003.


