AREA, TYPE LAND AND LOCATION:
A 0.23-acre parcel of State school land near
the City of Herlong, Section 35, T27N R16E,
MDM, Lassen County.

LAND USE: The operation and maintenance of an electrical
substation.

TERMS OF EXISTING LEASE:
Initial period: 25 years beginning March 24,
1978.

Surety bond: \$1,000.

Public liability insurance: Combined single
limit coverage of \$300,000.

CONSIDERATION: \$250 per annum.

OTHER PERTINENT INFORMATION:

1. The subject lease was issued on March 24, 1978 to CP National Corporation, for a period of 25 years, for the operation and maintenance of an electrical substation.
2. The Lessee has expressed its desire to assign its interest in the lease to Lassen Municipal Utility District, effective May 10, 1988, the date Lassen Municipal purchased the electric utility services from CP National.
3. The rental is paid for the lease through March 23, 1991.
4. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (14 Cal. Code Regs. 15061), the staff has determined that this activity is exempt from the requirements of the CEQA because the activity is not a "project" as defined by CEQA and the State CEQA Guidelines.


