MAINTENANCE DREDGING PERMIT

APPLICANT: Channel Reef Association  
2525 Ocean Blvd.  
Newport Beach, CA 92625

AGENT: Intracoastal Dredging  
P. O. Box 498  
Balboa Island, CA 92662

AREA, TYPE LAND AND LOCATION: Granted mineral reservation lands in Newport Bay at Corona Del Mar, Orange County.

LAND USE: Dredge a maximum 150 cubic yards of material to maintain a navigable depth at an existing boat slip.

The material will be used for replenishment of a public beach inside the harbor.

TERMS OF PROPOSED PERMIT:

Initial Period: One year beginning September 1, 1990.

Royalty: No charge for material used for beach replenishment for public benefit.

\$0.25 per cubic yard for material used for private benefit or sold.

PREREQUISITE TERMS, FEES AND EXPENSES:

Filing and processing fees have been received.

Under Section 15252 of the CEQA Guidelines, the State Lands Commission may use the environmental analysis made by the CCC in its consideration of this project.

Authority: Sections 21083 and 21087 of the CEQA.



IT IS RECOMMENDED THAT THE COMMISSION:

1. FIND THAT THE CALIFORNIA COASTAL COMMISSION, A FUNCTIONAL EQUIVALENT AGENCY UNDER SECTION 21080.5 OF THE CEQA, HAS CONSIDERED THE PROPOSED PROJECT AND DETERMINED THAT THE PROJECT, AS PROPOSED, WILL NOT HAVE A SIGNIFICANT EFFECT ON THE ENVIRONMENT.
2. FIND THAT THE COMMISSION HAS CONSIDERED THE INFORMATION CONTAINED IN THE ENVIRONMENTAL ANALYSIS PREPARED BY THE

CALIFORNIA COASTAL COMMISSION AND CONCURS WITH THE CONCLUSIONS AND FINDINGS CONTAINED THEREIN, 14 CAL. CODE REGS., SECTION 15252.


3. AUTHORIZE STAFF TO ISSUE TO CHANNEL REEF ASSOCIATION THE DREDGING PERMIT ON FILE IN THE OFFICE OF THE STATE LANDS COMMISSION. THE PERMIT SHALL ALLOW DREDGING A MAXIMUM 150 CUBIC YARDS OF MATERIAL FROM NEWPORT BAY AT CORONO DEL MAR, ORANGE COUNTY, FOR ONE YEAR BEGINNING SEPTEMBER 1, 1990. THE DREDGED MATERIAL WILL BE USED FOR PUBLIC BEACH REPLENISHMENT. NO ROYALTY SHALL BE CHARGED FOR MATERIAL USED FOR PUBLIC BEACH REPLENISHMENT. \$0.25 PER CUBIC YARD SHALL BE CHARGED FOR MATERIAL USED FOR PRIVATE BENEFIT OR SOLD. THE PERMITTED ACTIVITY IS CONTINGENT UPON THE APPLICANT'S COMPLIANCE WITH APPLICABLE PERMITS, RECOMMENDATIONS, OR LIMITATIONS ISSUED BY FEDERAL, STATE, AND LOCAL GOVERNMENT AGENCIES.




