**OTHER PERTINENT INFORMATION:**

1. On February 6, 1989, the Commission authorized the issuance of General Permit - Protective Structure Use, PRC 7275, jointly and severally to five parties who are contiguous owners of residences located at the toe of the bluffs at Isla Vista, Goleta, for the construction of a timber bulkhead seawall. Mr. and Mrs. Delle Donne have purchased the property from Mr. Gillespie, a co-lessee under the permit, and desired to have Mr. Gillespie's interest in the lease assigned to them.

This seawall was addressed by an Environmental Impact Report prepared by the County of Santa Barbara.
