AMENDMENT OF DREDGING PERMIT

APPLICANT:

Strawberry Recreation District
Attn: Stephen Kaufman

AREA, TYPE LAND AND LOCATION:

Granted mineral reservation lands in Richardson
Bay, Marin County.

LAND USE:

Dredge a maximum 35,000 cubic yards of material.
The Applicant has proposed disposal of the
dredged material at the Corps/EPA-approved
Alcatraz Disposal Site SF-11.

TERMS OF PROPOSED AMENDMENT:

Royalty:

No charge for aquatic disposal.
All other terms and conditions
of the permit shall remain in
full force and effect,
including the additional fee
charge of \$0.25 per cubic yard
to offset the cost of studies
necessary to develop non-Bay
disposal sites.

OTHER PERTINENT INFORMATION:

1. The original permit required payment of a royalty of \$0.25 per cubic yard for aquatic disposal. Under the proposed amendment, there will be no royalty charge. However, the "additional fee" charge of \$0.25 per cubic yard will remain in effect.

2. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (14 Cal. Code Regs. 15061), the staff has determined that his activity is exempt from the requirements of the CEQA under the general rule that CEQA applies only to projects which have the potential for causing a significant effect on the environment. The staff believes there is no possibility that this project may have a significant effect on the environment.

Authority: 14 Cal. Code Regs. 15061(b)(3).

IT IS RECOMMENDED THAT THE COMMISSION:

1. FIND THAT THE ACTIVITY IS EXEMPT FROM THE REQUIREMENTS OF THE CEQA PURSUANT TO 14 CAL. CODE REGS. 15061 BECAUSE THERE IS NO POSSIBILITY THAT THE ACTIVITY MAY HAVE A SIGNIFICANT EFFECT ON THE ENVIRONMENT. (14 CAL. CODE REGS. 15061(b)(3).

2. AUTHORIZE STAFF TO AMEND DREDGING PERMIT W 24397, WHICH WAS ISSUED TO STRAWBERRY RECREATION DISTRICT, EFFECTIVE SEPTEMBER 1, 1990, TO REFLECT THE FACT THAT A ROYALTY OF \$0.25 PER CUBIC YARD SHALL NOT BE CHARGED FOR AQUATIC DISPOSAL. ALL OTHER TERMS AND CONDITIONS OF THE PERMIT SHALL REMAIN IN FULL FORCE AND EFFECT, INCLUDING THE CHARGE OF THE "ADDITIONAL FEE" OF \$0.25 PER CUBIC YARD TO OFFSET THE COST OF STUDIES NECESSARY TO DEVELOP NON-BAY DISPOSAL SITES.



