**PUBLIC AGENCY PERMIT AND APPROVAL OF
RIGHT-OF-WAY MAP**

APPLICANT:

California Department of Transportation

AREA, TYPE LAND AND LOCATION:

An Approximate 4.554-acre parcel of sovereign land located
in the bed of the Navarro River, Humboldt County.

LAND USE:

Highway purposes pursuant to Section 101.5 of the Streets
and Highways Code, specifically to amend the existing map
and permit to include the placement of rock slope protection
in and along the Navarro River adjacent to Highway 1, in
Mendocino County.

TERMS OF PROPOSED PERMIT:

Indefinite period from date the permit is approved on behalf
of the State Lands Commission.

Consideration:

As set forth by Section 101.5, Streets and Highways
Code and the public use and benefit.

BASIS FOR CONSIDERATION:

Pursuant to 2 Cal. Code Regs. 2003 and Streets and Highways

OTHER PERTINENT INFORMATION:

1. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (14 Cal. Code Regs. 15061), the staff has determined that his activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 4, Minor Alteration to Land, 14 Cal. Code Regs. 15304.

Authority: P.R.C. 21084 and 14 Cal. Code Regs. 15300.

2. The Applicant is proposing to install rock slope protection on the embankment between Highway 1 and the Navarro River approximately ten miles south of the town of Mendocino. The project was initiated as a result of recurrent landslides in the area and will protect the highway from further erosion.
3. The annual rental value of the site is estimated to be \$819.72.
4. This amended map will increase the permit area from 3.6 acres to 4.554 acres.

APPROVALS OBTAINED:

Department of Fish and Game, California Coastal Commission waiver, United States Army Corps of Engineers, and North Coast Regional Water Quality Control Board waiver.




