MAINTENANCE DREDGING PERMIT

APPLICANT:

Sierra Boat Company
P. O. Box 69
Carnelian Bay, California 95711

AREA, TYPE LAND AND LOCATION:

Sovereign land in Lake Tahoe at the entrance channel to the
Sierra Boat Company marina at Carnelian Bay, Placer County.

LAND USE:

Dredge a maximum 960 cubic yards of material from the
entrance channel of the existing marina to maintain a
navigable depth of 6,219 feet determined to be a maintenance
level by the United States Army Corps of Engineers. The
dredged material will be stockpiled on the adjacent upland
and then trucked out of the basin for permanent disposal as
approved by the Tahoe Regional Planning Agency and Lahontan
Regional Water Quality Control Board.

TERMS OF PROPOSED PERMIT:

Initial period:

One (1) years beginning May 1, 1991.

Royalty:

\$0.25 per cubic yard for material placed at the
approved upland disposal site.

PREREQUISITE CONDITIONS, FEES AND EXPENSES:

Filing fee and processing fees have been received.

OTHER PERTINENT INFORMATION:

1. This activity involves lands identified as possessing significant environmental values pursuant to P.R.C. 6370, et seq. Based upon the staff's consultation with the persons originating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.
2. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (14 Cal. Code Regs. 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 4(g), Maintenance Dredging, where the dredged material is deposited in a disposal area authorized by all applicable State and Federal regulatory agencies, 14 Cal. Code Regs. 15104.

Authority: P.R.C. 21084 and 14 Cal. Code Regs. 15300.

APPROVALS OBTAINED:

Tahoe Regional Planning Agency, United States Army Corps of Engineers, Lahontan Regional Water Quality Control Board, and California Department of Fish and Game..

IT IS RECOMMENDED THAT THE COMMISSION:

1. FIND THAT THE ACTIVITY IS EXEMPT FROM THE REQUIREMENTS OF THE CEQA PURSUANT TO 14 CAL. CODE REGS. 15061 AS A CATEGORICALLY EXEMPT PROJECT, CLASS 4(g), MAINTENANCE DREDGING, 14 CAL. CODE REGS. 15104.
2. FIND THAT THIS ACTIVITY IS CONSISTENT WITH THE USE CLASSIFICATION DESIGNATED FOR THE LAND PURSUANT TO P.R.C. 6370, ET SEQ.
3. AUTHORIZE STAFF TO ISSUE TO SIERRA BOAT COMPANY THE DREDGING PERMIT FOR ONE YEAR, COMMENCING MAY 1, 1991, AUTHORIZING DREDGING A MAXIMUM 960 CUBIC YARDS OF MATERIAL TO MAINTAIN A NAVIGABLE DEPTH OF 6,219 FEET, DETERMINED TO BE A MAINTENANCE LEVEL BY THE UNITED STATES ARMY CORPS OF ENGINEERS, WITHIN LAKE TAHOE, AT THE ENTRANCE CHANNEL TO THE SIERRA BOAT COMPANY MARINA AT CARNELIAN BAY, PLACER COUNTY,

CALENDAR ITEM NO. C 0 9 (CONT'D)

AND UPLAND DISPOSAL AS APPROVED BY THE TAHOE REGIONAL PLANNING AGENCY AND LAHONTAN REGIONAL WATER QUALITY CONTROL BOARD. A ROYALTY OF \$0.25 PER CUBIC YARD SHALL BE CHARGED FOR MATERIAL PLACED AT THE APPROVED SITE. SUCH PERMITTED ACTIVITY IS CONTINGENT UPON APPLICANT'S COMPLIANCE WITH APPLICABLE PERMITS , RECOMMENDATIONS, AND LIMITATIONS ISSUED BY FEDERAL, STATE, AND LOCAL GOVERNMENT AGENCIES.


