AUTHORIZATION TO HOLD A PUBLIC HEARING  
UNDER GOVERNMENT CODE SECTION 126 REGARDING A  
CESSION OF CONCURRENT CRIMINAL JURISDICTION,  
NATIONAL TRAINING CENTER AND FORT IRWIN  
SAN BERNARDINO COUNTY

APPLICANT:

Fort Irwin, Department of the Army

The Secretary of the Army, acting through the United States Army Corps of Engineers, has requested that the State California cede to the extent permitted by law concurrent criminal jurisdiction over Fort Irwin, San Bernardino County. California Government Code Section 126 requires a public hearing be held to receive comments on the proposed cession and that the United States pay for the costs of the hearing.


