AWARD OF THE ROYALTY OIL SALES CONTRACT
STATE OIL AND GAS LEASES
PRC 145, PRC 410, PRC 429, PRC 427 AND PRC 1466
RINCON OIL FIELD, VENTURA COUNTY

BACKGROUND:

At its meeting on May 3, 1991, the State Lands Commission authorized the sale of royalty oil from State oil and gas leases PRC 145, PRC 410, PRC 429, PRC 427, and PRC 1466, Rincon Oil Field, Ventura County. The State's share of production from this lease is approximately 3,217 barrels per month of between 24.4° and 33.8° API gravity crude oil.

Texaco Trading & Transportation, Inc. is presently purchasing this oil and paying the State a bonus of \$0.2625 per barrel above a Base Price defined as the highest price posted for oil of like gravity and quality on the day of delivery in the Rincon Oil Field by Mobil Oil Corporation. This contract is scheduled to expire on December 1, 1991. Oil from these leases can be taken in kind or returned to the lessee on sixty days prior written notice.

A Notice Inviting Bids for a new royalty oil sales contract to run from December 1, 1991 until June 1, 1992 was published in the Ventura County Star Free Press on July 5, 1991. The bid opening was scheduled for July 23, 1991. Exhibit "A" shows the results of the bidding.

Fiscal and legal reviews of the submitted bid material were done by the State Lands Commission Auditing and Legal units, respectively. Based on the results of these reviews, the highest responsible bidder has been identified as Texaco Trading and Transportation, Inc. and is designated in Exhibit "A".
