GENERAL PERMIT - PUBLIC AGENCY USE

APPLICANT:

Department of Fish and Game
1416 Ninth Street
Sacramento, California 95814

AREA, TYPE LAND AND LOCATION:

A 13.8-acre parcel of State-owned land located in the
Tuolumne River, four miles east of Waterford, Stanislaus
County.

LAND USE:

Re-alignment of the river and the construction of gravel
beds for the restoration of salmon spawning and nursery
habitat and its maintenance.

TERMS OF PROPOSED PERMIT:

Initial period:
Fifteen (15) years beginning September 23, 1991.

CONSIDERATION:

The public use and benefit.

BASIS FOR CONSIDERATION:

Pursuant to 2 Cal. Code Regs. 2003.

Filing fee and processing costs have been received.

CALENDAR ITEM NO. C 30 (CONT'D)

OTHER PERTINENT INFORMATION:

1. The Department of Fish and Game proposes to enhance chinook salmon spawning and rearing habitat in the Tuolumne River by realigning and reshaping a half-mile of river channel and floodplain. Since the construction of new Don Pedro Dam in 1970, spawning has declined significantly due to lower water flows and the loss of natural gravel spawning areas. Historic gravel floodplains are now "perched" above existing stream flow levels thereby eliminating the river's ability to naturally replenish gravel. This project is an attempt to restore some of the salmon spawning run in this river.
2. This activity involves lands identified as possessing significant environmental values pursuant to P.R.C. 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.
3. The Department of Fish and Game will be responsible for monitoring all impacts identified in the Negative Declaration, SCH NO. 91072068.
4. The Department of Fish and Game will send, to the Commission, copies of reports prepared on the results of the monitoring conducted for this project.




