GENERAL PERMIT - PUBLIC AGENCY USE

**APPLICANT:**

State Reclamation Board  
1416 Ninth Street  
Sacramento, CA 95814

**AREA, TYPE LAND AND LOCATION:**

2,850 feet of levee at four sites along the Sacramento River  
at the Pocket Road area in the City of Sacramento,  
Sacramento County.

**LAND USE:**

Levee repair and reconstruction.

**TERMS OF PROPOSED PERMIT:**

Initial period:  
One (1) year beginning July 7, 1992.

**CONSIDERATION:**

The public health and safety; with the State reserving the  
right at any time to set a monetary rental if the Commission  
finds such action to be in the State's best interest.

**BASIS FOR CONSIDERATION:**

Pursuant to 2 Cal. Code Regs. 2003.

**APPLICANT STATUS:**

Applicant is permittee of upland.

**OTHER PERTINENT INFORMATION:**

1. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (14 Cal. Code Regs. 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 4, Minor Alteration to Land, 15304, 14 Cal. Code Regs.
2. The Project proponent, in its ongoing program to strengthen the levees along the Sacramento River in the urban area of Sacramento, discovered weakened and failed sections of levee at the Pocket Road area in the City of Sacramento, Sacramento County. Work has been initiated on the Pocket Road levee in order to forestall levee failure and will be completed before the winter rains. The area of the levee repair consists of four sites which total 2850 feet of levee.
3. This activity involves lands identified as possessing significant environmental values pursuant to P.R.C. 6370, et seq.

Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.

1. FIND THAT THE ACTIVITY IS EXEMPT FROM THE REQUIREMENTS OF THE CEQA PURSUANT TO 14 CAL. CODE REGS. 15061 AS A CATEGORICALLY EXEMPT PROJECT, CLASS 4 MINOR ALTERATION TO LAND, 15304, 14 CAL. CODE REGS.
2. AUTHORIZE ISSUANCE TO RECLAMATION BOARD OF AN ONE-YEAR GENERAL PERMIT - PUBLIC AGENCY USE BEGINNING JULY 7, 1992; IN CONSIDERATION OF THE PUBLIC HEALTH AND SAFETY, WITH THE STATE RESERVING THE RIGHT AT ANY TIME TO SET A MONETARY RENTAL IF THE COMMISSION FINDS SUCH ACTION TO BE IN THE STATE'S BEST INTEREST; FOR THE REPAIR AND RECONSTRUCTION OF THE DETERIORATED LEVEE ON THE LANDS DESCRIBED ON EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART HEREOF.
3. FIND THAT THIS ACTIVITY IS CONSISTENT WITH THE USE CLASSIFICATION DESIGNATED FOR THE LAND PURSUANT TO P.R.C. 6370, ET SEQ.

SACRAMENTO RIVER LEVEE REPAIR  
GREENHAVEN-POCKET AREA, PHASE II  
SACRAMENTO URBAN AREA  
SACRAMENTO COUNTY, CALIFORNIA.

All the State-owned land in the bed of the Sacramento River in Sacramento County, California, lying immediately beneath four proposed levee repair sites; sites one and two are shown on the Levee Repair Location Map, approved June 30, 1992, included as sheet 2 in the Department of the Army, Sacramento District, Corps of Engineer's Plans for Sacramento Urban Area Levee Reconstruction Project, Greenhaven-Pocket, Phase II, File No. 50-04-5862 on file in the Sacramento Office of the State Lands Commission; sites one and two are more particularly described as follows:

1	49	434+65 to 440+65	600 feet
2	49	444+50 to 448+50	400 feet



Army Engineer District at Sacramento California.
