OTHER PERTINENT INFORMATION:

1. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (14 Cal. Code Regs. 15061), the staff has determined that this activity is exempt from the requirements of the CEQA because the activity is not a "project" as defined by CEQA and the State CEQA Guidelines.

Authority: P.R.C. 21065 and 14 Cal. Code Regs. 15378.

2. The Assignor and assignee have agreed to July 1, 1993 as the effective date of the assignment of Lease PRC 3913; staff concurs in said date and recommends the same to the Commission for approval.
3. The above parties have additionally requested the assignment of lease PRC 1448, also effective July 1, 1993. Said lease covers a 0.05-acre parcel of sovereign lands running from October 25, 1954, through October 24, 2003, covering an 8-inch diameter water intake line. The staff has no objection to the assignment and so recommends it to the Commission. As above, this activity is exempt from CEQA because it is not a "project" as defined by CEQA and the State CEQA guidelines.


