OTHER PERTINENT INFORMATION:

1. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (14 Cal. Code Regs. 15061), the staff has determined that these activities are exempt from the requirements of the CEQA as a categorically exempt project(s). The projects are exempt under Class 1, Existing Facilities, 2 Cal. Code Regs. 2905 (a)(2) (Items A, B, D, E, and F; Class 3, New Construction, 2 Cal. Code Regs. 2905 (c)(1) (Items C, G and H).

Authority: P.R.C. 21084, 14 Cal. Code Regs. 15300, and 2 Cal. Code Regs. 2905.

2. The activities involve lands identified as possessing significant environmental values pursuant to P.R.C. 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the projects, as presented, are consistent with their use classification.

CODE REGS. 2905(a)(2) (ITEMS A, B, D, E, AND F; CLASS 3, NEW CONSTRUCTION, 2 CAL. CODE REGS. 2905 (c)(1) (ITEMS C, G AND H).
2. FIND THAT THESE ACTIVITIES ARE CONSISTENT WITH THEIR USE CLASSIFICATION DESIGNATED FOR THE LAND PURSUANT TO P.R.C. 6370, ET SEQ.


