INTERAGENCY AGREEMENT

APPLICANT:

Department of Fish and Game - Region 3
P.O. Box 47
Yountville, CA 94599

AREA, TYPE LAND AND LOCATION:

3496.52 acres of School land in Lake and Napa counties.

LAND USE:

Surface management of fish and wildlife resources.

TERMS OF ORIGINAL AGREEMENT:

Initial period: Ten years beginning December 1, 1982.

SPECIAL:

Any revenues generated from the use of the specified School lands by Department of Fish and Game will be deposited to the General Fund as required by P.R.C. 6217.5.

TERMS OF PROPOSED AGREEMENT:

Initial period: Ten years beginning December 1, 1992.

SPECIAL:

Any revenues generated from the use of the described lands will be deposited to the Teacher's Retirement Fund pursuant to Chapter 1213, Statutes of 1983.

PREREQUISITE CONDITIONS, FEES AND EXPENSES:

Processing costs have been received.

OTHER PERTINENT INFORMATION:

1. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (14 Cal. Code Regs. 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 7, 14 Cal. Code Regs. 15808, because it consists of an action taken by a regulatory agency to assure the maintenance, restoration, or enhancement of a natural resource.
2. This activity includes one 440-acre parcel of land identified as possessing significant environmental values pursuant to P.R.C. 6370, et seq. project, as proposed, is consistent with its use classification.
3. On November 29, 1982, the Commission approved an Interagency Agreement whereby Department of Fish and Game managed, on behalf of the Commission, the surface of 3496.52 acres of School land in Lake and Napa counties. That Agreement expired on November 30, 1992. The Department has requested a 10-year continuation of the Interagency Agreement.

IT IS RECOMMENDED THAT THE COMMISSION:

1. FIND THAT THE ACTIVITY IS EXEMPT FROM THE REQUIREMENTS OF THE CEQA PURSUANT TO 14 CAL. CODE REGS. 15061 AS A CATEGORICALLY EXEMPT PROJECT, CLASS 7, BECAUSE IT CONSISTS OF AN ACTION TAKEN BY A REGULATORY AGENCY TO ASSURE THE MAINTENANCE, RESTORATION, OR ENHANCEMENT OF A NATURAL RESOURCE, 14 CAL. CODE REGS. 15308.
2. FIND THAT THIS ACTIVITY IS CONSISTENT WITH THE USE CLASSIFICATION DESIGNATED FOR THE LAND PURSUANT TO P.R.C. 6370, ET SEQ.
3. AUTHORIZE THE EXECUTION OF THE INTERAGENCY AGREEMENT FOR SURFACE MANAGEMENT OF FISH AND GAME WILDLIFE RESOURCES BY DEPARTMENT OF FISH AND GAME FOR A TEN-YEAR PERIOD FROM DECEMBER 1, 1992, ON STATE SCHOOL LAND DESCRIBED IN EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART HEREOF.


