APPROVE THE SPECIFICATIONS AND FORMS FOR SALE OF  
CRUDE OIL BY THE CITY OF LONG BEACH FROM VARIOUS  
TRACTS WITHIN THE FAULT BLOCK IV UNIT AND  
FAULT BLOCK V RANGER ZONE UNIT,  
WILMINGTON OIL FIELD,  
LOS ANGELES COUNTY

BACKGROUND:

The City of Long Beach (City) has a crude oil sales contract with Ultramar, Inc., (Ultramar) for crude oil allocated to the City from certain tracts (listed on Exhibit "A") within the Fault Block IV Unit and Fault Block V Ranger Zone Unit. Some of these tracts are tidelands tracts. This sales contract commenced on February 1, 1993, and is scheduled to expire on February 1, 1994. Ultramar is paying the City a bonus of \$0.19 per barrel above a Base Price defined as the arithmetic average of the prices posted for oil of like gravity and quality in the Wilmington, Long Beach (Signal Hill), Huntington Beach and Inglewood Oil Fields on the day of delivery by Chevron, Mobil, Texaco and Union. The City's share of production from these tracts is approximately 600 barrels per day of 19° API gravity crude oil.

The City proposes to re-offer this oil for sale by competitive public bid under a new sales contract to commence on February 1, 1994, and to expire on February 1, 1995. Specifications for the sale are listed in Exhibit "B" to this Calendar Item.

The Long Beach City Council approved the bid package on July 13, 1993. The City now requests State Lands Commission approval of the bid package.

CALENDAR ITEM NO. C52 (CONT'D)

Under Section 10(a) of Chapter 29, Statutes of 1956, 1st E.S., the specifications and forms for the purpose of inviting bids for the sale of Long Beach tidelands crude oil must be approved by the State Lands Commission prior to the publication of the notice to bidders. The City plans to hold a bid opening on October 7, 1993. The Commission must then approve the awarding of this contract by the City.

EXHIBIT "B"

SPECIFICATIONS

Specifications of sale by the City of Long Beach of crude oil allocated to certain tracts in the Fault Block IV Unit and Fault Block V Ranger Zone Unit, Wilmington Oil Field, Los Angeles County, some of which are tidelands tracts.

1. Volume

The oil will be 100 percent of the City's working interest share of crude oil allocated to certain tracts within the Fault Block IV Unit and Fault Block V Ranger Zone Unit, Wilmington Oil Field, Los Angeles County. This is approximately 600 barrels per day of 19° API gravity crude oil.

2. Price

The biddable factor will be a bonus bid per barrel above a Base Price defined as the arithmetic average of the prices posted for like crude oil on the day of delivery in the Wilmington, Long Beach (Signal Hill), Huntington Beach and Inglewood Oil Fields by Chevron, Mobil, Texaco and Union.

3. Term

The contract will be for a term of twelve months commencing February 1, 1994 and expiring on February 1, 1995.

4. Surety

A Letter of Credit in the amount of Four Hundred Thousand Dollars (\$400,000) will be required as well as public liability and property damage insurance in amounts not less than Four Million Dollars (\$4,000,000).

5. Bid Deposit

A bid deposit of \$25,000 will be required which, except for the highest responsible bidder, will be returned.

6. Right to Reject Bids

The City reserves the right to cancel this offer at any time and to reject any and all bids received.
