1. The permit is conditioned on permittee's conformance with the shorezone ordinance of Tahoe Regional Planning Agency.
2. The permit is conditioned on the Cedar Flat Improvement Association's authorization and consent of the structure found to be on or adjacent to its lands.
3. The permit conforms to Lyon/Fogerty decision.

**CONSIDERATION:**

\$277.20 per annum; with the State reserving the right to fix a different rental on each fifth anniversary of the permit.

Pursuant to 2 Cal. Code Regs. 2003.

These two applications for assignment of this permit were initiated by the transfer of interest between our lessees and the sale of the littoral upland to Bruce W. Olson and Molly J. Olson, all without the prior authorization of the Commission.

2. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (14 Cal. Code Regs. 15061), the staff has determined that this activity is exempt from the requirements of the CEQA because the activity is not a "project" as defined by CEQA and the State CEQA Guidelines.

Authority: P.R.C. 21065 and 14 Cal. Code Regs. 15378.

3. This activity involves lands identified as possessing significant environmental values pursuant to P.R.C. 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the activity is consistent with its use classification.

2. FIND THAT THIS ACTIVITY IS CONSISTENT WITH THE USE CLASSIFICATION DESIGNATED FOR THE LAND PURSUANT TO P.R.C. 6370, ET SEQ.
3. APPROVE, EFFECTIVE SEPTEMBER 6, 1990, THE ASSIGNMENT OF GENERAL PERMIT - RECREATIONAL USE, PRC 4177, COVERING AN AREA UTILIZED BY A PIER FOR RECREATIONAL BOATING FROM ROBERT M. 
