80+-acre parcel of State school land situated in Humboldt  
County.

**LAND USE:**

Livestock grazing.

**PROPOSED LEASE TERMS**

Lease period:

Ten (10) years beginning June 1, 1993.

**Special:**

Lessee agrees that all grazing activity will be kept  
out of the riparian creek undergrowth.

**CONSIDERATION:**

\$500.00 per annum; with the State reserving the right to fix  
a different rental on the fifth anniversary of the lease.


