A parcel of submerged land lying in the bed of Donner Lake, in Nevada County, California, located in Lot 4 of the NE $\frac{1}{4}$  of Section 18, T 17 N, R 16 E, M.D.M., more particularly described as follows:

COMMENCING at a cross on the side of a twelve-foot boulder, said boulder being described in Book 554, page 380, Official Records of Nevada County; thence N 82° 21' 00" W, 140.15 feet to the TRUE POINT OF BEGINNING; thence along the following eight courses:

1. S 87° 39' 00" W, 106.50 feet;
2. S 02° 23' 00" E, 38.50 feet;
3. S 87° 39' 00" W, 26.50 feet;
4. N 02° 23' 00" W, 73.50 feet;
5. N 87° 39' 00" E, 38.00 feet;
6. S 02° 23' 00" E, 5.00 feet;
7. N 87° 39' 00" E, 74.50 feet;
8. S 39° 15' 00" E, 37.53 feet to the true point of beginning.

Bearings in this description are based on the southerly line of Old Highway 40, as shown on sheet 8 of State Highway Layout number 827, dated July 14, 1928.

A parcel of submerged land lying in the bed of Donner Lake, in Nevada County, California, located in Lot 4 of the NE $\frac{1}{4}$  of Section 18, T 17 N, R 16 E, M.D.M., more particularly described as follows:

COMMENCING at a cross on the side of a twelve-foot boulder, as said boulder is described in Book 554, page 380, Official Records of Nevada County; thence S 10° 31' 00" E, 59.50 feet to the TRUE POINT OF BEGINNING; thence along the following 4 courses:

1. N 76° 01' 00" W, 33.00 feet;
2. S 13° 59' 00" W, 29.50 feet;
3. S 76° 01' 00" E, 46.45 feet;
4. N 10° 31' 00" W, 32.45 feet to the true point of beginning.

Bearings in this description are based on the southerly line of old Highway 40 as shown on sheet 8 of State Highway Layout No. 827, dated July 14, 1928.


