 MOLINO OFFSHORE FIELD,

BACKGROUND:

State oil and gas lease PRC 2920, Molino Offshore Field, Santa Barbara County, was issued on August 28, 1962 to Shell Oil Company and Standard Oil Company of California, each with an undivided 50 percent interest in this lease. Through a series of name changes, the present lessees are Shell Western E&P, Inc. (Shell) and Chevron U.S.A., Inc. (Chevron) with Shell as the lease operator.

At its meeting on November 5, 1991, the State Lands Commission granted Shell a two year drilling deferment from October 1, 1991 through September 30, 1993. Shell is presently involved in a review of development scenarios and a subsea well abandonment project which requires environmental review and appropriate permits.

Shell has requested further deferment from October 1, 1993 through September 30, 1996. This will allow Shell to continue its study of a potential development project as well as completion of the environmental review for abandonment of existing idle subsea wells on the lease.
