CONTINUE WITH THE ANNUAL PLACEMENT OF A FISH  
BARRIER IN THE SAN JOAQUIN RIVER; PUBLIC USE AND  
BENEFIT WITH THE STATE RESERVING THE RIGHT AT ANY  
TIME TO SET A MONETARY RENTAL IF THE COMMISSION  
FINDS SUCH ACTION TO BE IN THE STATE'S BEST  
INTEREST; ON THE LAND DESCRIBED AND DEPICTED IN  
EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART  
HEREOF.


