CESSION OF JURISDICTION

DELEGATION OF AUTHORITY TO HOLD HEARING PURSUANT TO CALIFORNIA  
GOVERNMENT CODE SECTION 126 FOR CESSIONS AT LAVA BEDS NATIONAL  
MONUMENT, MODOC/SISKIYOU COUNTIES, WHISKEY TOWN NATIONAL  
RECREATION AREA, TRINITY COUNTY, POINT REYES NATIONAL SEASHORE,  
MARIN COUNTY, PINNACLES NATIONAL MONUMENT, MONTEREY/SAN BENITO  
COUNTIES, REDWOOD NATIONAL PARK, DEL NORTE/HUMBOLDT COUNTIES,  
DEVILS POST PILE NATIONAL MONUMENT, MADERA COUNTY

The United States through the Department of the Interior, National  
Park Service, has requested that the State of California cede  
concurrent criminal jurisdiction pursuant to California Government  
Code Section 126 over Lava Beds National Monument in Modoc and  
Siskiyou Counties, Whiskey Town National Recreation Area in Trinity  
County, Point Reyes National Seashore in Marin County, Pinnacles  
National Monument in Monterey and San Benito Counties, Redwood  
National Park in Humboldt and Del Norte Counties, and Devils Post  
Pile National Monument in Madera County.


Prior to a cession being granted, the Government Code requires that  
there be a public hearing in order to receive comments on whether  
such a cession would be in the best interests of the State. This  
Calendar Item requests the Commission to authorize the Executive  
Officer or his delegate to conduct the public hearing.


IT IS RECOMMENDED THAT THE COMMISSION:





LOCATION MAP


