**AUTHORIZE PREPARATION AND PROCESSING OF
A STATE PATENT TO BE ISSUED TO CHARLES W. WILLIAMS**

APPLICANT:

Sydney Ann Williams and Mary K. Williams have requested that a State patent be issued for 160 acres, more or less, of State-owned school land in Modoc County. An application for purchase of the parcel (Susanville Land District 6160) was filed by Charles W. Williams and approved by the Surveyor General on March 29, 1911, and a Certificate of Purchase 6118 showing payment made in full was issued on April 17, 1911. The original certificate of purchase is beyond the control of the present owners of the land and affidavits pursuant to P.R.C. 7729 have been provided. No patent has yet been issued to complete the chain of title on the parcel.

Staff has examined the file and other information submitted by Modoc County Title Company and has concluded that the laws relating to issuance of a patent for the described lands have been complied with, and that the person to be named in the patent (Charles W. Williams) is entitled to it. Sydney Ann Williams and Mary K. Williams are the successors-in-interest to Charles W. Williams.
