

FOR CONTINUED USE AND MAINTENANCE OF AN EXISTING 20 FT. BY
42 FT. SINGLE-BERTH FLOATING DOCK WITH RAMP AND APPROX.
487 YARDS OF EXISTING BANK PROTECTION; ON THE LAND DESCRIBED
ON EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART HEREOF.
