Monument No. 155 D.W. bears S 52° 09' 42" E 5,467.44 feet; thence from said POINT OF BEGINNING along said northerly bank S 77° 40' 00" W 293.83 feet and S 71° 59' 00" W 306.91 feet; thence leaving said northerly bank S 15° 14' 00" E 50.00 feet to a point in said San Joaquin River; thence N 74° 45' 47" E 600.00 feet; thence N 15° 14' 00" W 50.00 feet to the point of beginning.

EXCEPTING THEREFROM any portion lying landward of the ordinary high water mark of said San Joaquin River.
