LOCATION:

Tide and submerged lands granted to the City of Eureka, minerals reserved to the State, in the bed of the North Channel, Humboldt Bay, Humboldt County.

LAND USE:

Continued dredging of a maximum of 24,000 cubic yards (a maximum of 3,000 cubic yards per year) of material for maintaining a navigable depth at the Eureka Forest Products loading dock. The dredged material will be disposed of at an approved upland disposal site near Fieldbrook on the north line of S1/2 of SE1/4 Sec. 15, T7N, R1E, HBM.

OF AN EIGHT-YEAR DREDGING LEASE, BEGINNING JUNE 1, 1995; TO DREDGE MATERIAL FROM TIDE AND SUBMERGED LAND IN HUMBOLDT BAY, AS DEPICTED ON EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART HEREOF; NO ROYALTY SHALL BE CHARGED FOR DREDGED MATERIAL PLACED SO LONG AS THE PROJECT IS A PUBLIC BENEFIT. A MINIMUM OF \$0.025 PER CUBIC YARD ROYALTY SHALL BE CHARGED FOR MATERIAL USED FOR PRIVATE BENEFIT OR COMMERCIAL SALE PURPOSES.


