A parcel of submerged land located in the bed of Lake Tahoe at Jameson Beach, El Dorado County.

AUTHORIZED USE:

Continued use and maintenance of an existing recreational pier and one mooring buoy and the retention of one existing, unauthorized mooring buoy.

TERM:

Ten years beginning April 1, 1996

CONSIDERATION:

No monetary consideration pursuant to Section 6503.5 of the Public Resources Code.





LOCATION MAP


Lake Tahoe
