RECREATIONAL PIER LEASE

APPLICANT:

David K. Rippey
5000 Hillsdale Circle
El Dorado Hills, California 95762

LOCATION:

A parcel of submerged land located in the bed of Lake Tahoe, Sunnyside, Placer County.

AUTHORIZED USE:

Repair and maintenance of a pier, installation of a boat lift and retention of two existing, previously unauthorized mooring buoys.

TERM:

Ten-year lease, beginning October 28, 1996.

CONSIDERATION:

No monetary consideration pursuant to Public Resources Code Section 6503.5.

INFORMATION:**

This lease is conditioned on the Lessee obtaining authorization from the Tahoe Regional Planning Agency (TRPA) for the existing buoys within two years from the effective date of the authorization of the buoys by the Commission.






SITE MAP

 1970 West Lake Blvd.


LOCATION MAP




LOCATION MAP
