AREA, LAND TYPE, AND LOCATION:

Submerged lands in Lake Tahoe near Homewood, Placer County.

AUTHORIZED USE:

Maintenance of one mooring buoy.

LEASE TERM:

Ten years, beginning August 22, 1995.

CONSIDERATION:

No monetary consideration pursuant to Public Resources Code section 6503.5.

SPECIFIC LEASE PROVISIONS:

Insurance:

Liability insurance in the amount of no less than \$300,000.

OTHER PERTINENT INFORMATION:

The authorization for this Recreational Pier Lease No. PRC 7421.9, is being rescinded per Lessee's request. The lease covering Lessee's mooring buoy was approved by the Commission on May 9, 1996, for a ten-year period beginning August 22, 1995. However, prior to this authorization the buoy had been lost in a storm, and Lessee has recently decided not to re-install the buoy and no






