REVISION OF RENT

LESSEE:

Tosco Corporation  
2300 Clayton Road  
Concord, California 94520-2100

AREA, LAND TYPE, AND LOCATION:

10.6 acres, more or less, of tide and submerged lands in Suisun Bay, near Avon,  
Contra Costa County.

AUTHORIZED USE:

Marine petroleum wharf together with appurtenances.

LEASE TERM:

15 years, beginning July 26, 1964, with 3 ten-year renewal periods.

CONSIDERATION:

This lease provides that Lessor may modify the rent periodically during the lease term. Pursuant to this provision, Staff has conducted a review of the rent under this lease, and recommends that the rent be revised from \$51,046 per year to \$62,625 per year, effective January 1, 1997.

The recommended adjustment of rent is based on adjustment of the prior rent by application of the Consumer Price Index (CPI). Application of the CPI to adjust rents at this time is an interim measure necessitated by budget constraints and resultant losses of staff, and does not obligate the Commission to use the CPI to adjust rents other than as specifically set forth herein.




EXHIBIT "A"
