AREA, LAND TYPE, AND LOCATION:

Sovereign lands in the Napa River, south of the city of Napa, Napa County.

AUTHORIZED USE:

Use and maintenance of an existing boat ramp, foot ramp and float as shown on Exhibit A, attached hereto.

LEASE TERM:

Ten years, beginning February 1, 1997.

CONSIDERATION:

No monetary consideration pursuant to Public Resources Code section 6503.5.

SPECIFIC LEASE PROVISIONS:

Insurance:

Liability insurance: Combined single limit coverage of \$300,000.

OTHER PERTINENT INFORMATION:

- Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. 


