AREA, LAND TYPE, AND LOCATION:

4.59 acres, more or less, of tide and submerged land in the Pacific Ocean offshore of Pismo State Beach (now known as the Oceano Dunes State Vehicular Recreation Area), near the city of Santa Maria, San Luis Obispo County.

AUTHORIZED USE:

Maintenance and use of an 18-inch diameter wastewater outfall pipeline, and retention of existing abandoned 14-inch diameter wastewater outfall pipeline.

LEASE TERM:

49 years beginning October 25, 1954.

CONSIDERATION:

\$1,428 per year; with the State reserving the right to fix a different rent periodically during the lease term, as provided in the lease.

OTHER PERTINENT INFORMATION:

1. Applicant owns the uplands adjoining the lease premises.

2. Tosco Corporation has purchased the Santa Maria Refinery from Unocal, effective April 1, 1997.

EXHIBIT A
LAND DESCRIPTION

PRC 1449.1

A strip of tide and submerged land 100 feet wide in the Pacific Ocean near Oso Flaco Lake, San Luis Obispo County, California, said strip lying 50 feet on each side of the following described centerline:

BEGINNING at the westerly terminus of the pipeline easement centerline described in the deed to the Union Oil Company of California and recorded in Book 1755, Page 553, Official Records of San Luis Obispo County; thence along said pipeline and its prolongation N79°11'32"W, 2000 feet to the end of the herein described line.

EXCEPTING THEREFROM any portion lying landward of the ordinary high water mark of the Pacific Ocean.

The bearing in the above description is based on the California Coordinate System, Zone 5.




EXHIBIT B
