REVISION OF RENT

LESSEE:

Belardo Company
50 Bon Air Center, Suite 200
Greenbrae, California 94904

AREA, LAND TYPE, AND LOCATION:

0.06 acre, more or less, of sovereign lands in Corte Madera Creek, Greenbrae, Marin County.

AUTHORIZED USE:

Use and maintenance of an existing accommodation pier.

LEASE TERM:

Ten years, beginning September 1, 1991.

CONSIDERATION:

This lease provides that Lessor may modify the rent periodically during the lease term. Pursuant to this provision, staff has conducted a review of the rent under this lease, and recommends that the rent be revised from \$397 per year to \$424 per year, effective September 1, 1997.


