RECREATIONAL PIER LEASE

APPLICANT:

Michael LeMieux
130 Harbor Drive
Novato, California 94945

AREA, LAND TYPE, AND LOCATION:

Sovereign lands in the Petaluma River at Black Point, Marin County.

AUTHORIZED USE:

Use and maintenance of an existing pier, deck, ramp and floating dock as shown on attached Exhibit A.

LEASE TERM:

Ten years, beginning April 29, 1997.

CONSIDERATION:

No monetary consideration pursuant to Public Resources Code section 6503.5.

SPECIFIC LEASE PROVISIONS:

Insurance:

Liability insurance in the amount of no less than \$300,000.

OTHER PERTINENT INFORMATION:

1. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under Class 1, Existing Facilities; Title 2, California Code of Regulations, section 2905 (a) (2).
Authority: Public Resources Code section 21084 and Title 14, California Code of Regulations, section 15300 and Title 2, California Code of Regulations, section 2905.


SIGNIFICANT LANDS INVENTORY FINDING:

AUTHORIZATION:

AUTHORIZE ISSUANCE TO MICHAEL LEMIEUX OF A TEN-YEAR RECREATIONAL PIER LEASE, BEGINNING APRIL 29, 1997, FOR THE USE AND MAINTENANCE OF AN EXISTING PIER, DECK, RAMP AND FLOATING DOCK ON THE LAND SHOWN ON EXHIBIT A ATTACHED AND BY THIS REFERENCE MADE A PART HEREOF; NO MONETARY CONSIDERATION PURSUANT TO PUBLIC RESOURCES CODE SECTION 6503.5; LIABILITY INSURANCE IN THE AMOUNT OF NO LESS THAN \$300,000.

Area to be leased lies directly beneath docks, and walkway, plus a necessary use area 10 feet in width in front of proposed dock.
EXCEPTING THEREFROM any portion lying above the ordinary high water mark.


