**CONSIDER APPROVAL OF THE ASSIGNMENT OF PARTIAL INTERESTS
IN OIL AND GAS LEASES NOS. PRC 2199.1, PRC 2920.1 AND PRC 2894.1
SANTA BARBARA COUNTY**

BACKGROUND:

Oil and Gas Leases Nos. PRC 2199.1, PRC 2920.1 and PRC 2894.1 were issued between July 25, 1958 and August 28, 1962. The ownership of the leases is divided between Shell Western E&P, Inc., (SWEPI) and Chevron, USA (Chevron). Chevron and SWEPI own an undivided 50 percent interest in Lease Nos. PRC 2894.1 and PRC 2920.1. Leasehold interests in Lease No. PRC 2199.1 are as follows:

Chevron U.S.A., Inc.	North ½	100 Percent
Chevron U.S.A. Inc.	South ½	66-2/3 percent
Shell Western E&P, Inc.	South ½	<u>33-1/3 percent</u>
		100 percent

On August 3, 1994, the Commission approved SWEPI's assignment of its interest in the three leases to Molino Energy Company (Molino). As a result, Molino became the operator of Oil and Gas Lease No. PRC 2920.1. Chevron has now requested approval of assignment of its interest in the leases to Molino. In turn, Molino proposes to assign an undivided 40 percent interest in the leases to Benton Oil and Gas Company (Benton). Benton will subsequently become the operator under the leases. Molino is requesting Commission approval of the aforementioned assignment of interests in these leases.

3. CONSENT TO THE ASSIGNMENT OF AN UNDIVIDED 40 PERCENT INTEREST OF MOLINO ENERGY COMPANY'S INTERESTS IN THESE SAME LEASES TO BENTON OIL AND GAS COMPANY.
4. ASSIGNEE SHALL BE BOUND TO THE TERMS AND CONDITIONS OF THE LEASES TO THE SAME EXTENT AS THE ASSIGNOR, ANY CONDITIONS IN THE ASSIGNMENT AGREEMENTS TO THE CONTRARY NOT WITHSTANDING.
5. DELEGATE TO THE EXECUTIVE OFFICER OR HIS DESIGNEE, THE

ASSIGNMENT OF INTERESTS IN THESE OIL AND GAS LEASES.



SANTA BARBARA COUNTY




SANTA BARBARA CHANNEL
