REVISION OF RENT

LESSEE:

Southern California Edison Company
1851 W. Valencia, Building G
Fullerton, California 92833

AREA, LAND TYPE, AND LOCATION:

35.73 acres, more or less, of school lands in Section 36, T10N, R15E, SBM,
near the city of Needles, San Bernardino County.

AUTHORIZED USE:

Continued use and maintenance of an existing 500 kv transmission line.

LEASE TERM:

49 years, beginning August 28, 1968.

CONSIDERATION:

This lease provides that Lessor may modify the rent periodically during the lease term. Pursuant to this provision, staff has conducted a review of the rent under this lease, and recommends that the rent be revised from \$409.04 per year to \$582 per year, effective August 28, 1998.

The recommended adjustment of rent is based on adjustment of the prior rent by application of the Consumer Price Index (CPI). Application of the CPI to adjust rents at this time is an interim measure necessitated by budget constraints and resultant losses in staff, and does not obligate the Commission to use the CPI to adjust rents other than as specifically set forth herein.






EXHIBIT "A"
