RECREATIONAL PIER LEASE

APPLICANT:

Ronald J. Guerra and Russey J. Guerra
901 Sycamore Road
Pleasanton, California 94566

AREA, LAND TYPE, AND LOCATION:

Sovereign lands in Lake Tahoe, near Agate Bay, Placer County.

AUTHORIZED USE:

Continued use and maintenance of a pier and a mooring buoy, as shown on the attached Exhibit A.

LEASE TERM:

Ten years, beginning September 23, 1996.

CONSIDERATION:

No monetary consideration pursuant to Public Resources Code section 6503.5.

SPECIFIC LEASE PROVISIONS:

Insurance:

Liability insurance in the amount of no less than \$300,000.

Other:

The lease is conditioned on Lessee's obtaining authorization from the Tahoe Regional Planning Agency (TRPA) for the mooring buoy within two years from the effective date of the authorization of the buoy by the Commission.

OTHER PERTINENT INFORMATION:

1. Pursuant to the Commission's delegation of authority and the State CEQA Guidelines (Title 14, California Code of Regulations, section 15061), the staff has determined that this activity is exempt from the requirements of the CEQA as a categorically exempt project. The project is exempt under

2. This activity involves lands identified as possessing significant environmental values pursuant to Public Resources Code sections 6370, et seq. Based upon the staff's consultation with the persons nominating such lands and through the CEQA review process, it is the staff's opinion that the project, as proposed, is consistent with its use classification.


LOCATION MAP
